

ARTICLES OF ORGANIZATION OF VIRGINIA
LIMITED LIABILITY COMPANY
MONTICELLO FLYING CLUB, LLC.

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia the undersigned states as follows:

ARTICLE I
NAME

The name of the limited liability company is MONTICELLO FLYING CLUB, LLC. hereafter referred to as ("the Club").

ARTICLE II
REGISTERED AGENT AND REGISTERED OFFICE

The name and address of the registered agent of the Club shall be Michael James Vanderweide, a resident of the Commonwealth of Virginia and a member of the Club. The Club's initial registered office address, including the street and number, which is identical to the business office of the initial registered agent, is 4354 Chris Greene Lake Rd, Charlottesville, Virginia 22911, in the County of Albemarle.

The principal office for the transaction of the business of this Club is to be located at 4354 Chris Greene Lake Rd, Charlottesville, Virginia 22911 (County of Albemarle).

ARTICLE III
PURPOSES AND POWERS

The purposes for which the Club is organized and the powers which the Club shall possess are as follows:

1. To provide pleasure, recreation and for other non-profitable purposes for its members, substantially all of the activities of which are for such purposes and no part of the net earnings of which inures to the benefit of any member.
2. To provide opportunities for members to commingle and share their interest in and enjoyment of aviation and aviation related activities.
2. To own or lease and maintain one or more aircraft for the education, transportation, and general use of the Members of the Club or their families or such individuals as the Board of Directors may designate pursuant to any Operating Agreement which may hereafter be adopted.

3. To exercise the powers outlined in Chapter 12 of Title 13.1 of the Code of Virginia, except for those power prohibited by these Articles or any Operating Agreement which may hereafter be adopted.

ARTICLE IV
MEMBERS

The registered agent listed on this document will be the first member of the Club. He will solely approve additional members until an Operating Agreement is signed by the members, after which members shall be admitted as provided in the Operating Agreement. The Club will never deny membership based on race, color, gender, religion or national origin.

ARTICLE V
DISSOCIATION AND EXPULSION OF MEMBERS

Until the Operating Agreement is signed, members may dissociate per the terms of their joining agreement and the registered agent holds the sole authority to expel members. Upon signing of the Operating Agreement, the process for dissociation and expulsion of members will be per the Operating Agreement.

ARTICLE VI
MANAGERS

The registered agent will be the initial manager who shall exercise all authority of the Club and hold sole authority to act on behalf of the Club, including the option of delegating some of that authority, until an Operating Agreement is signed or upon a vote of the members to rescind the Operating Agreement. Upon signing of the Operating Agreement, the Club will be managed by managers (hereinafter "Directors") who will be periodically selected by the members of the Club from among themselves. The Board of Directors will then be the sole agents with the authority to act for the limited liability corporation as set forth in the Operating Agreement. The number of Directors shall be a minimum of one (1) and a maximum of a number equal to the number of Members of the Club. All managers must be members of the Club.


ARTICLE VII
OPERATING AGREEMENT

From time to time, the Members and/or Directors of the Club may adopt and amend an Operating Agreement in accordance with Chapter 12 of Title 13.1 of the Code of Virginia. Such Operating Agreement, if any, shall be binding on all Members and Directors of the Club.

ARTICLE VIII
NOT FOR PROFIT

The Club shall be operated as a not for profit social club, and no part of the net earnings of the Club will inure to the benefit of any Member.
